ORDER

The appeal No.12 dated 22/9/2014 filed by Shri Soni Kumar, under Section 19 of the RTI Act, 2005 regarding his RTI Application (ID No.73) was heard on 10/10/2014 at 11:00 AM by the undersigned in his capacity as First Appellate Authority. The PIO & APIO were present but the appellant didn't turn up. A representative of the appellant named Mr. Pardeep Sharma appeared for the hearing with authority letter of the appellant.

The PIO informed that applicant has sought the copy of MLC of applicant Soni Kumar and other co-accused person namely Sandeep Kumar and Prem Kumar conducted at your hospital on 10/7/2012 and 11/7/2012 by the police officials of P.S. J.P. Kalan in case FIR No.76/12. Accordingly, it was replied to the applicant that the information sought is a Medico Legal document that can not be given to anybody other than the concerned Police Authority investigating the case without any explicit court orders. Further, the same records are also exempted under Section 8 (1) (b) and 8 (1) (h) of RTI Act, 2005.

The representative of the appellant desired to know whether the MLC of Shri Soni Kumar was made or not on 10/07/2012 and requested for a copy of the MLC. In response, the PIO informed that on 10/07/2012, one MLC for Medical Examination in respect of Shri Soni Kumar was prepared by the CMO on duty. Further, copy of MLC could not be provided as it is a Medico-Legal Report and the same can be provided on court directions.

Keeping in view the observation of PIO, it found that the reply given by the PIO was substantially correct. Hence, the appeal was disposed off.

In case, the appellant is not satisfied with decision, he may file a Second Appeal under RTI Act, 2005 within 90 days from the issue of this order before the Information Commissioner, Central Information Commission, Room No.326, IInd Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066.
