## ORDER

The appeal filed by Shri S. Kumar, under Section 19 of the RTI Act, 2005 regarding his RTI Application dated 12/2/2014 vide RTI ID No.126 received in the office of PIO on 14/02/2014 (Annexure-I).

The appellant in his Appeal No.16 dated 18/3/2014 received in this office on 27/03/2014 (Annexure-II) alleged that he has not received reply to his above mentioned RTI. On scrutiny of record, it was found that RTI Application was received in the office of PIO on 14/02/2014 and the same was duly replied by the PIO on 14/3/2014 (Annexure-III) within stipulated period of 30 days. The RTI was appropriately replied and the applicant was also requested to deposit a sum of Rs.70/- for obtaining the information contained in 35 pages.

On 05/04/2014, the appellant personally came to the office of PIO and submitted his request alongwith requisite fee (**Annexure-IV**) in reference to PIO's reply dated 14/3/2014 for obtaining the copies of 35 pages and the same were sent to the appellant on 05/04/2014 (**Annexure-V**). The appellant has also withdrawn his first appeal dated 18/03/2014 vide his request dated 05/04/2014 (**Annexure-IV**).

In view of the above facts, it is found that there was no delay on part of PIO and the appellant has also received the PIO's reply dated 14/3/2014. Accordingly, the appeal is disposed off.

In case, the appellant is not satisfied with decision, he may file a Second Appeal under RTI Act, 2005 within 90 days from the issue of this order before the Information Commissioner, Central Information Commissioner, Room No.326, II<sup>nd</sup> Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066.
