**ORDER** 

The appeal No.7 filed by Shri Mukesh Kuamar Dagar, under Section 19 of the RTI Act, 2005 regarding his **RTI Application (ID No.31)** had been fixed earlier for hearing on 21/08/2014 at 11:00 AM. Accordingly, the appeal was heard on 21/08/2014 at 11:00 AM in the presence of the Appellant, the PIO and APIO.

2. The Appellant raised the points of his RTI one by one and the PIO replied on the points raised by the appellant. The contention of the appellant and response of the PIO are recorded as under:

i) Reg. Reply to Question No. 1 to 7: The appellant has already been provided all the information sought by the appellant in 7 questions on the basis of information available with concerned branch.

Decision of FAA: The contention of PIO was found reasonable and also agreed by the appellant.

The appellant contended that he filed this RTI mainly to focus on the facilities provided to the pregnant women who visit Gynaecology department. The PIO stated that it has already been informed to the appellant that there is the provision of waiting area in Gynaecology department which can accommodate approx. 75 patients and there is provision of water cooler and air cooler is being made. Now, two air cooler & water cooler have been installed and are functional in the waiting area of the patients. The appellant was asked to submit his suggestion, if any, in order provide better facilities to Gynaecology patients.

Accordingly, the appeal was disposed off.

In case, the appellant is not satisfied with decision, he may file a Second Appeal under RTI Act, 2005 within 90 days from the issue of this order before the Information Commissioner, Central Information Commission, Room No.326, II<sup>nd</sup> Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066.
