ORDER

The appeal filed by Shri Surender Rathore, under Section 19 of the RTI Act, 2005 regarding his RTI Application (ID No.103) had been fixed earlier for hearing on 13/05/2014 but due to exigency the hearing was re-fixed for 15/05/2014 at 11:00 AM. Accordingly the appeal was heard on 15/05/2014 at 11:00 AM. The PIO & APIO were present but the appellant didn't turn up as the process of decision ex-parte was being considered. A representative of the appellant named Mr. Sumit Yadav appeared for the hearing at 12:10 PM without any authority letter of the appellant and stated that appellant had some urgent / sudden domestic problem.

The undersigned after satisfying that the representative came with the original hearing notice preferred to give him a chance. It was stated by the appellant in his appeal that he had not received the copy of driving licence based on which Shri Sukhbir Singh was appointed for the post of Driver in the year 2000 and the copy of FIR provided by PIO didn't show the licence no., date and place of issue. The appellant had requested for all the above relevant information regarding driving licence of Shri Sukhbir Singh to be given to him. The PIO was asked to clarify the status in the matter.

The PIO stated that all copies of educational qualification certificates and copy of FIR lodged by the Shri Sukhbir Singh, Driver regarding lost of his driving licence had already been provided to the appellant. PIO further stated that as per service record available Shri Sukhbir Singh was initially appointed as Nursing Orderly on 17/04/2000 by the DHS and later on he was promoted to the post of Driver on 22/12/2006 by the TRC, Health & Family Welfare Deptt, Govt. of NCT of Delhi vide their office order No.F.4(77)/85/MC/TRC/ Vol.III/2005/4344 dated 14/12/2006 and he was posted at LNJP Hospital and then he was transferred from LNJP Hospital to RTRM Hospital on 22/12/2006 and since then he is working as driver.

In view of the above statement of the PIO it is clear that Shri Sukhbir Singh was promoted to the post of Driver by the TRC, Health & Family Welfare Deptt, Govt. of NCT of Delhi in the year 2006. Therefore, the appellant is advised to obtain the copy of relevant driving licence from TRC, Health & Family Welfare Deptt, Govt. of NCT of Delhi.

Accordingly, the appeal was disposed off.

In case, the appellant is not satisfied with decision, he may file a Second Appeal under RTI Act, 2005 within 90 days from the issue of this order before the Information Commissioner, Central Information Commission, Room No.326, IInd Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066.
