Medical Superintendent of Rao Tula Ram Memorial Hospital, Jaffarpur, New Delhi invites sealed tenders under two bid system (Pre-qualification cum Technical Bid and financial Bid) for Calibration work of Medical Equipments & Instruments as per the list enclosed herewith (Annexure V) in Rao Tula Ram Memorial Hospital, Govt. of N.C.T. of Delhi, Jaffarpur, New Delhi-110073.

The interested agencies are required to submit the Pre-qualification cum technical and financial bids separately. The bids in sealed cover-I containing "Pre-qualification cum Technical Bid ([Annexure II](#) AND Requisite Documents)" and Sealed cover-II containing "Financial Bid ([Annexure III](#))" should be placed in a third cover bearing the words "**Tender for Calibration work of Medical Equipments & Instruments at RTRMH**" and should be deposited in tender box in CSSD branch of Rao Tula Ram Memorial hospital on or before 19/08/2020 at 01:00 PM.

Intending eligible bidders may obtain a copy of bid document from the CSSD Branch of Rao Tula Ram Memorial Hospital, Jaffarpur, New Delhi-73 on any working day between 10:00 AM to 03:00 PM (Monday to Friday) and 10:00AM to 12:00 Noon (Saturday) on payment of Rs. 200/- (Rs. Two Hundred) in the form of cash /crossed Demand Draft/Banker's cheque from any Nationalised Bank/Commercial Bank in Delhi/New Delhi drawn in favour of the " Medical Superintendent" Rao Tula Ram Memorial Hospital, Jaffarpur, New Delhi 73.

1.2 VALIDITY OF TENDERS: - The validity of tender will be for a period of one year from the date of Award of Contract. The validity is extendable on mutual consent of both parties i.e. bidding firm and Hospital on the same rates and terms and conditions further to a maximum of one year subject to the satisfactory performance.

1.3 PROCEDURE FOR SUBMITTING TENDERS

The tender shall be submitted online. EMD and Annexure II must be submitted in physical format in original to be dropped in sealed cover in Tender Box kept in Purchase Branch before the due date and time of bid closing time.

- i. **EMD:** - The bidder shall upload the scanned copy of Earnest Money Deposit for Rs 6,000/- only (Rs. Six Thousand Only) in the form of Fixed Deposit Receipt (FDR)/Bank Guarantee (BG) favouring Medical Superintendent – Rao Tula Ram Memorial Hospital, Jaffarpur, New Delhi, valid for at least 45 days beyond the final bid validity period (minimum 165 days from the last date of bid submission) from Nationalized/Commercial Bank.
- ii. However, Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or are registered with the Central Purchase Organisation or the concerned Ministry or Department are exempted from depositing the Earnest Money on production of the said registration with scope of maintenance and calibration services of medical equipments & instruments from Ministry of Micro and Small-Scale Industries, GOI or any other body specified by M/o, MSME. The certificate must be valid as on Bid closing date of the tender.
- iii. MSME who have applied for registration or renewal of registration but have not obtained the valid certificate as on date of tender are not eligible for exemption.

- iv. The Start-up firms should meet capability to execute work as per scope of services. The agencies must be in the Calibration Services for Medical Equipments and Instruments.
- v. The Start-up Company must upload certificate of registration issued by the Department of Commerce and Industries, Government of India with scope of maintenance and calibration services of medical equipments & instruments.
- vi. Start-up agencies are exempted from EMD.
- vii. Provision for MSME/START-UP VERIFIED registered firms can be considered for exemption from Technical Capacity as required in Para 1.4 (8) as per terms and conditions of MSME/START-UP VERIFIED firms.
- viii. In the event of the withdrawal/revocation of tenders before the date specified for acceptance, the earnest money shall stands forfeited. The EMD will however be returned without interest to the tenderer whose tender is not accepted.
- ix. EMD of the successful bidder shall only be returned after submission of Performance Guarantee. The EMD will be forfeited if the successful bidder fails to submit acceptance / Performance Guarantee.
- x. The Performance Guarantee will be forfeited if the successful bidder fails abide by the terms & conditions in toto.
- xi. The Performance Guarantee shall remain valid for a period of 60 days beyond the date of completion of all contractual obligations. In case the contract period is extended further, the validity of Performance Guarantee shall also be extended by the contractor accordingly. Performance Guarantee shall be released after expiry of the validity of tender. Subject to compliance to all other tender terms & condition. **The hospital shall not pay any interest on Performance Guarantee.**
- xii. EMD is liable to be forfeited if the tender withdraws or transfers to other or impairs or derogates the bid in any respect.

1.4 PRE-QUALIFICATION /TECHNICAL BID: -

The bids in sealed cover-I super scribed “**Pre-qualification cum Technical Bid for Calibration work of Medical Equipments and Instruments**” containing following documents:

1. Original EMD; In case of MSME and Start up; EMD is exempted subject to submission of valid registration certificate with scope of maintenance and calibration services of Medical Equipments and Instruments.
2. Details as per Annexure II on letter head of the firm.
3. Undertaking as per Annexure –I.
4. An Under taking on Non-Judicial Stamp Paper of Rs. 10/- for No Criminal Liability of bidder and his personnel/manufacturer duly attested and stamped by Notary Public on prescribed Performa (Annexure-IV).
5. In case of partnership, the self attested copy of authorization to sign the tender document should be submitted by the other partner/partners.
6. In case of partnership, self attested partnership deed.
7. Authorization from proprietor/owner to sign the tender documents in case the owner/proprietor is not signing the tender document.
8. Self attested Copy of firm Incorporation Certificate from Government Organization.
9. Self attested Copy of Proof of filing Income tax return for the year 2016-17, 2017-18 and 2018-19.
10. Self attested Copy of PAN card of firm / proprietor.

11. Self attested Copy of GST registration certificate
12. Must have executed satisfactorily (i) one work order of value not less than Rs 1,52,000/- (Rs One Lac Fifty Two Thousand) or (ii) two work orders of value not less than Rs 1,14,000/- (Rs One Lac Fourteen Thousand) or (iii) three work orders of value not less than Rs 76,000/- (Rs Seventy Six Thousand) for calibration of medical equipments and instruments during last five years calculated backwards from last date of bid submission in any Govt. Hospital/ NABH Accredited Pvt. Hospitals of at least 100 beds. **Certificate from Authorized signatory from hospital must be produced for providing satisfactory calibration services.**
13. **Valid NABL Accreditation Certificate with Scope of Accreditation of the bidding firm.**

1.5 PRICE BID: -

The bidder shall submit sealed cover-II super scribed “**Price Bid for Calibration work of Medical Equipments and Instruments**” containing Price Bid Annexure III. Price to be quoted for all equipments and instruments listed in Annexure V. Partial submission of bids will be rejected. Price Bid should be submitted in cover II only. Any Information regarding the Prices in Prequalification cum Technical Bid (cover I) will lead to rejection of the bid.

- i. The prices should be quoted as per Annexure III.
- ii. The rates should be quoted in Indian Rupee in whole figures. Decimal point if any will be ignored.
- iii. L-1 will be considered as successful bidder on the basis quoted price. **There will be two rounds of calibration in each year at six months interval. Calibration once done will be valid for six months. In between this period calibration if required will be done free of cost within 7 days.**
- iv. The quoted rates will include all costs including GST.
- v. The bidder must satisfy himself that he has the capacity and infrastructure to calibrate all items mentioned in Annexure - III along with fulfilling terms and conditions.
- vi. The bid shall be summarily rejected, if a bidder fails to quote rate or quote “0/nil” in the price bid.
- vii. In case the quoted prices are same for two or more bidders, in that case lottery system will be adopted for selection of the successful bidder from among the L-1 bidders, who may wish to be present on the occasion.
- viii. The prices will be firm and final and no increase in quoted rates will be considered during the period of contract.
- ix. **If any consumable will be required for calibration of any equipments and instruments the cost will be borne by the successful bidder.**

1.6 Hospital may seek any query during PQ cum Technical Evaluation subject to condition that it does not affect eligibility criteria in any way for already submitted documents.

1.7 PAYMENT: - Payment will be made on half yearly basis after accomplishing satisfactory calibration work duly signed by the concerned HOD/HOU. No advance payment will be made.

1.8 PENALTY CLAUSE

- i. The work should be completed within 30 days from the date of work order and submit the satisfactory work done report from the respective department.
- ii. The bidder will be bound to complete the calibration work within stipulated period, failing which a penalty of 1% of the value of order per working day will be imposed subject to a maximum of 10% of total value of orders.
- iii. The tender will be cancelled and security deposit will be forfeited in case of repeated delay and non responding.

1.10 RISK PURCHASE:-

In case the tender fail to provide services within scheduled time, the hospital reserves the right to procure the services and the loss to the Govt. on account of excess expenditure incurred will be charged from the approved firm.

SECTION 2: SPECIAL TERMS AND CONDITIONS

- 2.1 All the Bills are to be submitted in triplicate. Bill should be pre-receipted with application of Revenue Stamp wherever necessary. Care should be taken to submit the bills duly completed and without any errors to prevent rejection / cancellation / delay in processing of bills.
- 2.2 Normally part services or part bill will not be accepted. However, in exceptional circumstances the same may be accepted at the sole discretion of the competent authority of the hospital, against clear written request with explanation from the firm.
- 2.3 **Recovery of Sums Due:** Whenever any claim for the payment of a sum of money arises out of or under this contract against the Service Provider for Calibration, the Hospital shall be entitled to recover of such sum by appropriating, in part or whole the Security Deposit deposited by the Service Provider for Calibration, when the balance or the total sum to be recoverable, as the case may be shall be deducted from any sum then due or which at any time thereafter may become due to recoverable under this or any other contract with the Hospital. Should this sum not be sufficient to cover the full amount recoverable, the Service Provider for Calibration shall pay to the Hospital on demand the remaining balance due.
- 2.4 **Insolvency and Breach of Contract:** The Medical Superintendent may at any time by notice in writing summarily terminate the contract without compensation to the Service Provider for Calibration in any of the following events, that is to say:-
 - i. If the Service Provider for Calibration being an individual or if firm, any partner in the Service Provider for Calibration's firm, shall at any time be adjudged insolvent or shall have a receiving order or orders for administration of his estate made against him or shall take any proceedings for liquidation or composition under any insolvency not for the time being in force or shall make any convenience or assignment of his efforts or enter into any arrangements or composition with his creditors or suspend payment of if the firm be dissolved under partnership act, or
 - ii. If the Service Provider for Calibration being a company shall pass a resolution or the court shall make an order for the liquidation of the affairs or a receiver of

Manager on behalf of the debenture holder shall be appointed or circumstances shall have arisen which entitled the court or debenture holders to appoint a receiver or Manager.

- iii. If the contract commits any breach of this contract not herein specifically proved for: Provided always that such determination shall not prejudice any right of action or remedy which shall have accrued or shall accrue thereafter to the Hospital and provided also that the Service Provider for Calibration shall be liable to pay the Hospital for any extra expenditure, he is thereby put to but shall not be entitled to any gain on repurchased.

2.5 Statutory Requirements: The agency will fulfil all statutory requirements as under the current laws. In the event of any violation of laws, rules, statutory provisions by the Service Provider for Calibration, this will amount to breach of contract and in such case, the hospital will have the right for terminating the contract, forthwith, without giving any notice or assigning any reason.

2.6 Right to Accept / Reject: The hospital authority reserves the right to reject any or all tender without assigning any reason whatsoever.

2.7 Assistance to Service Provider for Calibration: The Service Provider for Calibration shall not be entitled to assistance either, in the procurement of raw materials required for the fulfilment of the contract or in the securing of transport facilities.

2.8 Validity of Contract: The contract, if awarded, shall be valid initially for one year from the date of award of contract. **The validity is extendable on mutual consent of both parties i.e. bidding firm and Hospital on the same rates and terms and conditions further to a maximum of one year subject to the satisfactory performance.**

However, on failure satisfactory services, the hospital will have the right to terminate the contract forthwith in addition to forfeiting the security amount deposited by the Service Provider for Calibration and initiating administrative actions for black listing etc. solely at the discretion of the hospital authority.

2.9 The successful agency shall have to enter in to an agreement with the Hospital and the cost incurred in this connection, shall have borne by the Service Provider for Calibration.

2.10 The rate once accepted by the hospital shall remain unaltered through the period of contract, including any extended period.

2.11 Acceptance by the Hospital shall be communicated in due course. You are requested that the instruction contained in the said communication should be acted upon immediately/as asked for.

2.12 The tenderer should provide the complete Postal Address, Telephone / Mobile / E-mail address while submitting the complete tender form.

2.13 Name & active Mobile No. of one key person, who can be contacted at any time, must also be submitted. The person should be capable of liaising with the hospital/departmental authorities to calibrate the desired items.

2.14 Attested copy of necessary certificate from authorised Signatory should be enclosed.

2.15 The firm should be responsible if any mishap take place on account of non-conformities of safety standards and rules on their part.

2.16 INSPECTION OF EQUIPMENTS/INSTRUMENTS: -

The prospective bidders/authorised personnel may inspect the equipment/instrument during the validity of tender after due intimation and recording all information and duly signed in the register kept in Repair & Maintenance Section and submit a report to the hospital.

2.17 The payment to the Service Provider for Calibration will be made mandatorily by electronic mode such as RTGS/NEFT etc. The Service Provider for Calibration is instructed to supply the following information along with the tender.

2.18 All communication will be through email only. The bidders must provide official email address and will look for any communication received on regular basis from Hospital. Hospital will not be responsible for any delay in response by the bidder on this account. Non provision of official email will lead to disqualification.

2.19 The information provided regarding number; make and model may have minor variation. The bidder may satisfy himself by actual inspection of the equipments and instruments regarding their specifications and other details to be calibrated. The decision of Medical Superintendent will be final.

2.20 The final bills submitted will be based on the actual equipments and instruments calibrated. The number may vary from the list in the tender.

2.21 Hospital may not submit any equipment/instrument if it is under repair at the time of calibration.

2.22 **SECURITY DEPOSIT as Performance Guarantee:** 10% value of the contract order as security deposit is to be deposited in the form of FDR/Bank Guarantee. It should be valid for 14 months from the date of contract and the same will be retained till the validity of contract. Validity of the Performance Guarantee will have to be extended for one year in case of extension of the contract.

2.23 On due performance and completion of the contract in all respects, the Security Deposit will be returned to the Service Provider for Calibration without any interest on presentation of an absolute 'No Demand Certificate' in the prescribed form and upon return in good condition of any specification.

2.24 DISPUTES AND ARBITRATION

- i. All disputes or differences arising during the execution of the contract shall be resolved by mutual discussion failing which the matter will be referred to the Medical Superintendent, RTRMH, Govt. of NCT of Delhi for nomination of sole arbitrator and decision by the arbitrator by arbitration act.
- ii. No Interest of any kind can be levied on the hospital for pending payment. Hospital will be liable to pay only part of Principal amount if due without any additional interest.

Section 3: SCOPE OF WORK:

- 3.1 **The tenderer will execute the work at the destination/space defined by the consignee in good order (of which Medical Superintendent, RTRMH be the sole judge) within the limits of the time as deemed reasonable and specify in such quantities/qualities as may be ordered by him from time to time.**
- 3.2 Work shall be certified as completed subject to inspection by Medical Superintendent, RTRMH, Jaffarpur or his assigned representative. Any Defect found in the work done will render the work open to rejection and decision of the Medical Superintendent, RTRMH shall be final and legally binding.
- 3.3 The bidder shall not sublet, transfer or assign the contract or any part thereof.
- 3.4 Test Laboratory and equipments used for calibration should be NABL Accredited.
- 3.5 The equipments and instruments should be calibrated at Hospital site and at the same location.
- 3.6 The calibration testing must be done by qualified and trained personnel only.
- 3.7 **Calibration report should be submitted within 10 days of completion of work.**
- 3.8 **Traceability Certificates should be submitted along with Calibration Reports.**
- 3.9 **The calibration testing should be done twice in one year at six months interval at the same quoted rates. In between this period calibration if required will be done free of cost within 7 days.**
- 3.10 No Advance payment will be done.
- 3.11 No damage to any of the equipments/instruments shall be caused during/out of the calibration process. If any damage occurs, the service provider shall be responsible for the repair/replacement of the same to the satisfaction of the competent authority at their own risk and cost. The decision of the Medical Superintendent in such cases will be final and binding to the bidder.
- 3.12 **EXCLUSIVE RIGHT OF MEDICAL SUPERINTENDENT**
Medical Superintendent, RTRMH, Jaffarpur, New Delhi has the full and exclusive right to accept or reject any or all the tenders without assigning any reasons, whatsoever.
