In the event of non-availability of PG degree/diploma holder, MBBS with minimum 02 years post MBBS experience out of which 01 year should be in Government Hospital in the specialty concerned. However, the offer of appointment will be given on Adhoc Basis to a non PG candidate and would stand terminated during any time of tenure in the event of joining of a PG candidate. If suitable candidate is not found in any category, the seat will be filled by other category candidates purely on adhoc basis

Age Limit: For SR, below 45 years as on date of interview (age relaxation is allowed to eligible candidates as per Central Government Rules for SC/ST/OBC etc.)
